**Financial year end 31 December 2018**

**Opinion**

We have audited the financial statements of The Sacred Heart Missionary Education Trust for the year ended 31 December 2018 which comprise the profit and loss, the balance sheet, the statement of changes in equity and notes to the financial statements, including a summary of significant accounting policies set out in note 3. The financial reporting framework that has been applied in their preparation is Irish law and FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland.

In our opinion the financial statements:



**Financial year ended 31 December 2018**

**1. General information**

The Sacred Heart Missionary Education Trust has confirmed it will hold investments and other assets in trust for the Religious congregation known as the Missionaries of the Sacred heart.

As the Missionaries of the Sacred Heart holds the beneficial interest in all of the investments and other assets, it incurs all costs associated with the properties held in trust for it. Accordingly the directors have prepared the financial statements of the company for the year under review on the going concern basis.

These financial statements are the company's financial statements for the financial year beginning 1 January 2018 and ending 31 December 2018.

**2. Statement of compliance**

The entity financial statement have been prepared in compliance with FRS 102, 'the Financial Reporting Standard applicable in the UK and Republic of Ireland'.

**3. Summary of significant accounting policies**

The significant accounting policies used in the preparation of the entity financial statements are set out below. These policies have been consistently applied to all financial years presented, unless otherwise stated.

(a) Basis of preparation

The entity financial statements have been prepared under the Historical cost convention.

(B) Taxation

No liability to corporation tax arises by reason of the company having no taxable income and no expenditure.

**Critical accounting judgements and estimation uncertainty**

Estimates and judgement made in the process of preparing the entity financial statements are continually evaluated and are based on historical experience and other factors, including expectation of future events that are believed to be reasonable under the circumstances.

There are no critical accounting Judgements or estimates included in thses financial statements.

**4. Administration expenses**

Expenses for auditor's remuneration and other expenses incurred in the financial years ended 31 December 2018 were borne by the Provincial Council. None of the directors received remuneration in respect of their services to the Company in either financial year.
